#### 1. Call to Order and Introductions

Chairperson David Mohler called the meeting to order at 10:00 A.M. and then read the meeting accessibility statement, and the Title VI Notice of Protection Statement. Charles Kilmer conducted the roll and announced there was a quorum present.

#### 2. Public Comments

There were no public comments offered at this time.

#### 3. Minutes of the October 19, 2021 Meeting

Chairperson Mohler asked the MPO Members for comments or changes regarding the minutes of the October 19, 2021 meeting.

Lee Hartmann made a motion and Mary Waldron seconded to endorse the minutes of the October 19, 2021 meeting.

There being no changes, the Old Colony MPO then voted unanimously via roll call vote to endorse the minutes of the October 19, 2021 Old Colony MPO Meeting.

#### 4. Brockton Area Transit (BAT) Report

Michael Lambert thanked MassDOT for a number of grants that BAT received through the Community Transit Grant Program (CTG). These grants will provide subsidies for BAT's Avon/Stoughton Service, Rockland Flex Service, and some replacement vans.

December showed an improvement in terms of year over year ridership. BAT ridership is at about 60% compared to pre-Covid. BAT continues to collaborate closely with employees to make sure people are up to date on vaccines and then noted that tests are available.

Pam Haznar provided an update on several projects under design or construction. They are as follows:

- Kickoff meeting was held in November 2021
- Waiting for project schedule

#### 6. FFY 2022-2026 Transportation Improvement Program (TIP) Amendments and/ or Adjustments

There are currently no Amendments and/ or Adjustments for the TIP as this time.

#### 7. Performance Based Planning and MassDOT Proposed Calendar Year (CY) 2022 Highway Safety Performance Measure Targets (PM1)

 Discussion, and Possible Adoption of the Proposed Set of Federally Required Performance Measure Targets Pertaining to Highway Safety

Derek Krevat provided a presentation on the Proposed Calendar Year (CY) 2022 Highway Safety Performance Measure Targets (PM1).

#### **Fatalities**

- Due to reduced vehicle miles traveled (VMT) related to the pandemic, 2020 data was disregarded given the unique circumstances surrounding data from that year
- CY 2022 projections are based on a 2.5% reduction in fatalities from CY 2021
- Target for CY 2022 is to reduce the number of total fatalities to 340, or .56 fatality rate (per 100 million VMT)

#### **Serious Injuries**

- Due to unpredictable fluctuations between 2019 and 2020 data and an overall decreasing trendline, a 3% reduction in annual serious injuries from 2018 to 2021, and a 4% annual reduction from 2021 to 2022, were assumed to calculate the CY 2022 target
- Target for CY 2022 is to reduce the total number of serious injuries to 2,504, or 4.11 serious injury rate (per 100 million VMT)

#### **Non-Motorized Fatalities and Serious Injuries**

- To project the non-motorist fatality and serious injuries for 2022, a 2% reduction was estimated
- Target for CY 2022 is to reduce the number of non-motorist fatalities and injuries to 471

Brady Winsten asked if the percent reduction targets are based purely on past trends. Derek Krevat stated that they are essentially based on past trends. Derek Krevat suggested that MassDOT's Strategic Highway Safety Plan presents the safety strategies being used.

Charles Kilmer asked how MPO members may participate in providing input into the development of

the 2023 Strategic Highway Safety Plan. Derek Krevat stated that there is a meeting scheduled that is open to all MPO members, and that there will additional opportunities in the future as the plan is developed.

Chairperson Mohler asked if there is a motion to adopt the Proposed CY 2022 Highway Safety Performance Measure Targets (PM1). A motion was made by Lee Hartmann and seconded by Michael Lambert.

The Old Colony MPO then voted unanimously via roll call vote to adopt the Proposed CY 2022 Highway Safety Performance Measure Targets (PM1).

#### 8. High Priority Corridor Screening Assessment Status Report

Guoqiang Li provided a status report on the High Priority Corridor Screening Assessment that is programmed in the FFY 2022 Old Colony UPWP. Staff are developing a High Priority Corridor Study Screening Assessment process for federal aid and functionally classified arterial roads, including state number routes. Staff will identify, rank, and inform the selection process for locations to conduct corridor studies that will then inform the Long-Range Transportation Plan (LRTP) Needs Assessment in the next few months. This project will apply a comprehensive approach to analyzing problems and forming recommendations ensuring that the needs of all transportation users are considered.

#### Proposed Project Evaluation Criteria Components:

- Capacity (Congestion)
- Safety
- Bicycle and Pedestrian Accommodation
- Climate resilience
- Criticality Factor (supporting the land use and business)
- Transit Operation
- Transportation Equity (Environmental Justice)
- Implementation Potential
- Physical Conditions

#### **Estimated Timeline for Project Completion:**

- Develop GIS database to manage candidate project scoring January 2022
- Verify traffic data, update Synchro and SimTraffic Simulation March 2022
- Develop base year Travel Demand Model to verify volume and travel time results March 2022
- Develop and validate network scoring April 2022
- Select final projects May 2022
- Develop technical reports, maps and results summary June 2022
- Provide project presentation July 2022
- Gather comments and suggestions on Draft August 2022

Final project completion – September 30, 2022

Pam Haznar commented that this information will be valuable for developing future TIP projects and

additionally for smaller improvements that communities can take on.

# February 15, 2022 Old Colony MPO Meeting Agenda Item 6 Development of FFY 2023-2027 Old Colony Transportation Improvement Program (TIP)

 Review of Projects including Evaluation Criteria and Results of TIP Readiness Day

#### **Summary**

The development of the FFY 2023-2027 Transportation Improvement Program (TIP) is underway. The TIP serves as a prioritized listing of highway, bridge, and transit projects for implementation during the next five (5) federal fiscal years that reflect the needs of the regional transportation system. In addition, the TIP is fiscally constrained based on expected federal funding, and it contains projects that are consistent with the Long Range Transportation Plan (LRTP).

#### **TIP Readiness Days**

Held annually, TIP Readiness Days is a collaborative process of gathering information and discussing currently programmed projects, and candidate projects being considered for programming.

During the information gathering phase, MPOs provide preliminary review of the FFY 2022-2026 Regional Priority Projects list and advise if the specific projects are intended to be programmed in the currently programed FFY or a different FFY. The MPOs also offer additional projects for review and potential programming consideration. Concurrently, MassDOT Districts, Right-of-Way Bureau, Environmental Offices, Program Managers, and Section Directors review the projects and offer comments on project status and readiness.

Following the information gathering phase, MassDOT and the MPO staffs meet to interactively review the status and readiness information for the projects. The result is a recommend year of programming for the projects reviewed.

#### **Transportation Evaluation Criteria**

During TIP development, current and proposed projects are evaluated using Transportation Evaluation Criteria (TEC). Projects are evaluated using the Transportation Evaluation Criteria of Condition, Mobility, Safety and Security, Community Effects and Support, Land Use and Economic Development, and Environmental Effects. The MPO staff uses the transportation evaluation criteria results, as well as readiness information, available funding, to develop scenarios for Preferred Set of Projects for MPO review, discussion, and consideration.

#### **Summary**

Though the Old Colony MPO's FFY 2022 Unified Planning Work Program, Old Colony Planning Council is conducting Road Safety Audits at high crash locations throughout the region. This program builds upon the FFY 2021 program, through which OCPC prepared road safety audits at a total of fifteen locations. The locations were in the communities of Abington, Bridgewater, Brockton, East Bridgewater, Easton, Hanover, Kingston, Plymouth, Stoughton, and West Bridgewater.

In November 2021, OCPC prepared a Road Safety Audit for the intersection of Massapoag Avenue at Mill Street in Easton. Both potential short term lower cost improvements and longer-term capital improvement projects were identified though this Audit and included in the final report, which has been distributed to stakeholders.

Road Safety Audits are currently being scheduled for the following locations:

#### Abington (Scheduled for February 23, 2022)

- Groveland Street and Linwood Street
- Central Street Corridor

#### **Brockton**

- Warren Avenue at Market Street
- West Chestnut Street at Southworth Street

#### Duxbury (Scheduled for February 18, 2022)

- Summer Street (Route 53) at Franklin Street and High Street
- Congress Street (Route 14) at Franklin Street
- Tremont Street / Enterprise Street (Route 3A) at Tremont Street / Church Street (Route 139)

Old Colony Planning Council is collaborating with municipalities and MassDOT to schedule additional audits throughout the region. These additional locations will be based on updated Equivalent Property Damage Only (EPDO) scores for crashes that occurred from January 1, 2019 through December 31, 2021. The EPDO is a calculated weighted value for intersections that assigns 21 points for crashes that resulted in an injury or fatality, and a single point for crashes resulting in property damage only.

A Road Safety Audit (RSA) is the formal safety performance examination of an existing or future road or intersection by an independent, multidisciplinary team. It qualitatively estimates and reports on potential road safety issues and identifies opportunities for improvements in safety for all road users. Old Colony Planning Council uses the Road Safety Audit process to achieve safety performance goals of reducing the number of serious injuries and fatalities on the roadway network.

## February 15, 2022 Old Colony MPO Meeting Agenda Item 8 Freight Planning and Action Plan Overview

#### **Summary**

The ongoing freight planning study efforts are focusing on a number of tasks based on FHWA guidelines in freight planning. These guidelines include integrating freight planning into the overall planning process, identify and plan for long-term freight needs, develop specific long-range transportation projects, identify potential funding sources for those projects.

The elements and process of the Freight Study include:

- 1. Freight Self-Assessment
  - Identify the key freight facilities and modes (truck, rail, port, air), industries, freight generators
  - Understand freight transportation needs (issues such as truck routes, bottlenecks/congestion, truck exclusions, physical constraints, crash locations and safety
  - Identify the major freight players in the region
- 2. Identify action freight related strategies, policies, and projects specific to the region that could be implemented into the MPO's plans and programs.

3. Integrate Freight Plan with the region's Long Range Transportation Plan

Discussions included in the study and report include:


- Consider existing MassDOT performance measures and targets
- Review rest area locations for long-distance truck drivers in the region, and the requirements of Jason's Law
- Identify possible traffic bottlenecks and safety concerns
- Freight project identification

## Self-Assessment (Freight Profile)

What is the freight transportation infrastructure? The physical and operational attributes available for each modal system, key routes and facilities, industry use, physical condition, and traffic volumes.

Commodity flow summary that describes the tonnage and value of freight shipments moving into, out of, through, and within the region.

Other transportation-related factors, such as economic development, land-use, safety, and environmental impacts. The combination of these components provides an illustration of what the regional freight system is, how it is being used, and how it impacts the community (and vice versa).

# Freight Planning Issues - Discussions

How is the system network used, and what are its weaknesses or congestion/bottlenecks? What about locations on the network that are safety concerns (compile truck crashes).

Develop mapping – major roadways, inter-modal connectors, railroads, inter-modal terminals, port facilities, and airports. Map the congestion, bottlenecks and flag locations where safety is a problem.

Review aggregate commodity flow data. The Freight Analysis Framework and CFS are available from FHWA and BTS providing commodity flow profiles for states. These geographic levels are larger than an MPO region, they can provide general characteristics for the region, key commodities, mode shares, and inbound outbound.

Summarize key socioeconomic data. Review key regional trends in employment and population growth including types of employment and overall growth throughout the region. (Census Bureau or Bureau of Economic Analysis, state sources).

Review rest area locations for long-distance truck drivers in the region, and the requirements of Jason's Law.

Consider Mass DOT performance measures and targets





Work with MassDOT to develop/compile TTTR for Truck Routes (Although TTTR is specific for trucks, all PM are important for freight movement)





Truck parking shortages are a national safety concern along with the associated safety risks.

Section 1401 of MAP-21, "Jason's Law," addresses the commercial motor vehicle parking shortage at public and private facilities along the National Highway System (NHS). It directs the USDOT to survey and:

- 1. Evaluate the capability of each State to provide adequate parking and rest facilities for commercial motor vehicles engaged in interstate transportation;
- 2. Assess the volume of commercial motor vehicle traffic in each State; and
- 3. Develop a system of metrics to measure the adequacy of commercial motor vehicle parking facilities in each State.

#### **Summary**

#### Route 24 Over Canton Street Bridge Replacement Virtual Design Public Hearing

A Virtual Design Public Hearing was hosted by MassDOT to present the design for the proposed Route 24 Over Canton Street Bridge replacement project in Randolph, MA. on **February 10, 2022 at 6:00 PM**.

MassDOT proposes to replace the superstructures of two single-span bridges carrying Route 24 over Canton Street using accelerated bridge techniques in order to limit major roadway impacts to two weekend closures. The proposed bridges will match the footprint of the existing bridges and maintain existing clearance. Existing sidewalks and striped shoulders on both sides of Canton Street underneath the bridges will remain. The project proposes new safety barriers and deck drains on the bridge, as well as repairs to the concrete abutments. Please note this meeting will be recorded and transcribed by a stenographer. ## Route 138 (Washington Street) Corridor Improvements Project Virtual Design Public Hearing

A Virtual Design Public Hearing will be hosted on the MassDOT website below to present the design for the proposed Route 138 (Washington Street) Corridor Improvements project in **Stoughton**, MA. on **February 16**, **2022 at 6:00 PM**. The purpose of this project is to improve traffic safety and operation of Route 138. The project consists of milling and overlay of the existing pavement, limited widening at some locations, adding turning lanes at intersections, new pavement markings, sidewalk reconstruction and new sidewalk, and traffic signal and signage replacement. Pedestrian accommodations consist of 6-foot-wide sidewalks (on both sides of the street, except north of York Street which is on one/west side only). Bicycle accommodations consisting of a 7-foot-wide buffered bike lane on each side of the street are in accordance with applicable design guides.

The Bipartisan Infrastructure Law (BIL) appropriated \$1.5 billion to be awarded by the U.S. Department of Transportation for National Infrastructure Investment grants under RAISE. This is the first year of the RAISE Transportation Discretionary Grants program under the BIL. The grant program funds will be awarded on a competitive basis for surface transportation infrastructure projects that will have a significant local or regional impact. ## **Culvert Replacement Municipal Assistance Grant - Now Accepting Applications Notice of Grant Opportunity**

The Division of Ecological Restoration (DER), Massachusetts Department of Fish and Game, seeks proposals from Massachusetts municipalities interested in replacing undersized, perched, and/or degraded culverts located in areas of high ecological value. The purpose of this funding is to encourage municipalities to replace culverts with better designed crossings that meet improved structural and environmental design standards and climate resiliency criteria. In general, **individual awards have ranged from \$25,000 to \$400,000 for single culvert replacements**, depending on the project phases and work proposed. Awards over \$200,000 are anticipated for construction projects only.

Only projects that intend to meet the goals of the Massachusetts Stream Crossing Standards will be considered for funding. Projects should be designed to facilitate fish & wildlife passage, maintain the natural movement of water and sediment through the stream crossing, and reconnect upstream and downstream habitat. Use of these Standards to design culverts improves river function and access for fish and wildlife, and reduces hazards to public safety, such as flooding, culvert failure, and road washout.

Massachusetts municipalities are eligible to apply for funding to support advancing single or multiple culvert replacement project(s) on the same local connected stream network toward completion.
