

Accelerating Clean Transportation (ACT) **School Bus: Fleet Deployment**

AMOUNT: \$2,000,000 DEADLINE: June 24, 2024

> The ACT School Bus Fleet Deployment program offers school bus fleets flexible funding for depot upgrades and purchase of electric school buses and associated charging infrastructure.

Participating fleets have the opportunity to partner with the Massachusetts Clean Energy Center to address gaps in technical knowledge and in areas such as coordination with stakeholders, equipment selection, procurement, and project implementation.

Clean Heavy-Duty Vehicles Grant

AMOUNT: \$500,000 - \$60 Million **DEADLINE:** July 25, 2024

- The Inflation Reduction Act invests \$1 billion to replace existing nonzero-emission heavy-duty vehicles with zero-emission vehicles, support zero-emission vehicle infrastructure, and to train and develop workers.
- At least \$400 million will be used to fund projects serving communities located in an area in nonattainment with the National Ambient Air Quality Standards. The EPA will offer funding to eligible recipients to replace existing non-zero-emission Class 6 and 7 heavy-duty vehicles with eligible Class 6 and 7 zero-emission vehicles. To support zero-emission vehicle adoption and deployment, funding may also be used for:
 - zero-emission vehicle refueling infrastructure.
 - workforce development and training.
 - project implementation costs.

Through this SMART Notice of Funding Opportunity (NOFO), USDOT will accept applications for Stage 1 Planning and Prototyping grants. Later this year, recipients of Stage 1 grants will be eligible to expand their projects through the first of several Stage 2 grant opportunities.

The funding opportunity is open to public sector entities seeking to carry out transportation projects that demonstrate at least one of the following technology areas:

- Delivery/logistics
- Innovative aviation
- Smart grid
- Traffic signals

- Coordinated automation
- Connected vehicles
- Sensors
- Systems integration









OCPC Grantology







