#### 1. Call to Order and Introductions

Noreen O'Toole called the meeting to order at 12:03 P.M. and then read the Meeting Accessibility Statement and the Title VI Notice of Protection Statement. Bill McNulty then conducted the roll call.

#### 2. Public Comments

There were no public comments at this time.

#### 3. Minutes of March 7, 2024 Meeting

Chairperson O'Toole asked if there is a motion to approve the March 7, 2024 Meeting Minutes. A motion was made by Dan Salvucci and seconded by Don Howard to approve the Meeting Minutes from March 7, 2024.

The Old Colony JTC voted unanimously via roll call to approve the March 7, 2024 Meeting Minutes.

#### 4. Communications

Shawn Bailey reviewed the contents of the communications staff report. Included were letters of correspondence, as well as notices of workshops and conferences. They are as follows:

#### 5. Reports

#### A. Brockton Area Regional Transit Authority (BAT)

Michael Lambert reported on the following items:

- BAT reported that March 2024 ridership was 25 percent higher than March 2019 ridership before the COVID-19 pandemic.
- BAT reported 20,000 trips along the Stoughton Route.
- BAT is implementing a bus shelter replacement program, replacing existing shelters and installing shelters at new locations. These shelters include solar lighting and signage.

#### B. Greater Attleboro-Taunton Regional Transit Authority (GATRA)

Mary Ellen DeFrias reported on the following items:

- GATRA is continuing to roll expand Sunday service.
- GATRA is experiencing a driver shortage.
- GATRA is reviewing routes across their service area to see where headways may be able to be reduced and service hours expanded.

Mary Ellen DeFrias was asked what communities are included in GATRA's service area. She explained the service area goes down to Wareham and up through Plymouth, Kingston, Bellingham, Taunton and Attleborough. There are 30 communities in GATRAs service area. Service hours are 6 AM – 7 PM.

#### C. South Coast Rail Project

Shawn Bailey reported on the following:

In March 2024, work conducted involved fencing installation in six communities; daytime roadway sign installations near stations in Middleborough and Taunton; construction of a pedestrian bridge over Route 18 in New Bedford (night work and detours to resume week of April 7); return of Mass Coastal Railroad nighttime freight operations on the New Bedford Main and Fall River Secondary lines; daytime brush cutting and tree trimming along the railroad right-of-way in eight communities; and signal system installation and testing in seven communities.

Additional work done included daytime construction and signal work at station sites, layover sites, and along the right-of-way from Middleborough to New Bedford as well as from Berkley to Fall River. There was also transportation of soil by truck to designated project sites.

Chairperson O'Toole asked the timeframe. Shawn Bailey stated that the current estimate for commencement of SCR revenue service is late Summer/Early Fall of 2024.

On March 19, 2024, the Old Colony Metropolitan Planning Organization endorsed the Old Colony FFY 2024-2028 Transportation Improvement Program as adjusted with Adjustment 2.

Rosemary Connolly asked for a status update on Project 613643 – Corridor Improvements on South Avenue in Whitman. Dan Salvucci stated that Bruce Martin submitted the application for the TIP. Bill McNulty stated that this project was evaluated during the Transportation Evaluation Criteria evaluation process, and while it was not selected for programming in the Preferred Set of Projects for FFY 2025-2029 it remains an active project and will be considered in future TIPs.

Charles Kilmer stated that in terms of readiness, this project was just approved by the MassDOT Project Review Committee. This is very early in the design stage, so readiness was another factor. It's in the TIP itself but it is not in the current funding cycle. Keep pushing forward with the design and the MPO will consider for the next funding cycle.

#### 7. New Business

A. Old Colony FFY 2025-2029 Transportation Improvement Program (TIP) Development – Review and Discussion of Preferred Set of Projects

Bill McNulty discussed the preferred set of projects and statewide projects for inclusion in the FFY 2025-2029 TIP.

On March 19, 2024, the Old Colony Metropolitan Planning Organization selected a Preferred Set of Projects to be included in the development of the Draft Old Colony FFY 2025-2029 Transportation Improvement Program (TIP). The Preferred Set of Projects includes \$164 million in highway and bridge investments and over \$64 million in transit investments across the Region.

The Draft Old Colony FFY 2025-2029 Transportation Improvement Program is scheduled for release to a public review and comment period pending MPO approval on April 16, 2024.

- C. Old Colony Traffic Volumes Report, 1993-2023
  - Presentation and Discussion

Kyle Mowatt presented and discussed the Traffic Volumes Report.

The *Old Colony Traffic Volumes Report (1993-2023)* contains traffic information from the past 30 years from a variety of sources including Old Colony Planning Council, Massachusetts Department of Transportation (MassDOT), and various consulting and engineering firms.

During each count season the completed Automatic Traffic Recorder (ATR) counts are uploaded to the <u>Transportation Data Management System (MS2)</u>. MS2 is a tool to organize traffic count data. It allows the ability to upload data from a traffic counter; view graphs, lists and reports of historic traffic count data; search for count data using either the database or the Google map; and print or export data to your desktop. The process of storing count data in MS2 involves collecting traffic count data, uploading count data, verifying count data quality, and assigning count data to count locations.

Chairperson O'Toole asked if there were any patterns seen while looking at the traffic patterns. Kyle Mowatt stated that with Covid there was definitely a drop in traffic volume. There is usually a gradual increase of 1% in traffic. The numbers seem to be still off a bit with a lot of people still working from home.

Charles Kilmer provided an example in the Volumes Report of how the ADT has varied through the years. The historical nature of the count locations is a great resource.

Dan Murphy stated that this will be a great resource. He also commented on the great cover photo of the report in East Bridgewater.

#### 8. Other Business and Public Comment

#### A. Community Local Technical Assistance Studies

Bill McNulty reported on the following items:

The Old Colony Planning Council completed a traffic study of High Street, Maple Avenue, and Vernon Street in Bridgewater. Traffic data and findings from this Study have been distributed to the Town.

This should be looked at to determine if a police officer is needed during school release hours. Celia Canavan said that she will pass this along to Mayor Sullivan, and hopefully we can come up with a solution.

Bruce Hughes stated that Abington passed their MBTA Community Housing Issue at their Town Meeting.

## What is happening?

From Friday May 3 to Monday May 6, the northbound bridge along Route 24 in Randolph will be replaced. Route 24 and Canton Street below the bridge will be impacted. Weather and unexpected circumstances make all construction activities subject to change, but we will do our best to keep you updated.

How will this affect you?

Route 24 - Timing: 8 p.m. on Friday May 3 to 4 a.m. on Monday May 6.

**Details:** As vehicles approach the bridges, travel lanes will be reduced from three lanes to two. Northbound traffic will be shifted onto the southbound bridge which will carry two lanes in

each direction. After passing through the work zone, vehicles will return to the normal traffic pattern along Route 24.

**Details:** During the closure, Canton Street will be closed to vehicles, pedestrians, and cyclists. Vehicles will be redirected on an 11-mile detour along state roads.



## **MassDOT - Online Grant Management Tool: Grant Central**

The Massachusetts Department of Transportation on May 2 will launch an online grant management tool for municipalities called Grant Central.

Cities and towns can use the portal, spearheaded by MassDOT's Highway Division, to apply for program funding, submit project requests, and submit expense reimbursement requests.

Starting on May 2, according to MassDOT, all Chapter 90 project requests will be submitted through Grant Central (which replaces MaPIT).

Additional programs that will soon use Grant Central include:

- Complete Streets
- Local Bottleneck Reduction
- Municipal Pavement
- Municipal Small Bridge
- Shared Streets and Spaces

Beginning in mid-May, cities and towns will be able to use the portal to apply for grant programs as regularly scheduled grant rounds open. MassDOT will continue to communicate with municipalities about application deadlines for programs as the details become available.

## **Summary**

The South Coast Rail (SCR) project will restore commuter rail service between Boston and southeastern Massachusetts by spring/summer 2024. Taunton, Fall River, and New Bedford are the only major cities within 50 miles of Boston that do not currently have commuter rail service to Boston. SCR will reconnect this region to jobs and generate economic development.

South Coast Rail consists of two phases:

Phase 1 will provide a one-seat ride by extending the existing Middleborough/Lakeville commuter rail line from Boston to Taunton, Fall River, and New Bedford and it will deliver service to the South Coast by summer/fall 2024.

Full Build plans to extend Commuter Rail service to continue travel on the Stoughton branch of the Providence/Stoughton line, connecting to more communities in the region. Doing so would result in reconstructing the Canton Center and Stoughton stations to accommodate two rail lines.

In April 2024, work conducted involved fencing installation in five communities; overnight work and train testing in four communities; construction of a pedestrian bridge over Route 18 in New Bedford (night work and detours resumed week of April 7 and closures began April 16<sup>th</sup>); bus service between Bridgewater and Middleborough/ Lakeville stations from April 27<sup>th</sup> through May 5<sup>th</sup> to allow for work on the project; brush cutting and tree trimming along the railroad right-of-way in three communities; and signal system installation and testing in seven communities.

Additional work done included daytime construction and signal work at station sites, layover sites, and along the right-of-way from Middleborough to New Bedford as well as from Berkley to Fall River. There was also transportation of soil by truck to designated project sites.

The development of the FFY 2025-2029 Transportation Improvement Program (TIP) is underway. The TIP serves as a prioritized listing of highway, bridge, and transit projects for implementation during the next five (5) federal fiscal years that reflect the needs of the regional transportation system. In addition, the TIP is fiscally constrained based on expected federal funding, and it contains projects that are consistent with the Long-Range Transportation Plan (LRTP).
