Virtual Design Public Hearing - Duxbury - Bridge replacement, Route 3 (Pilgrim Highway) NB/SB over Franklin Street

A Virtual Design Public Hearing will be hosted on the MassDOT website provided below to present the design for the proposed Bridge Replacement Route 3 (Pilgrim Highway) NB/SB over Franklin Street Project on **October 6, 2022 at 6 p.m.**

The proposed project consists of the construction of a new northbound bridge in the existing median and reconstruction of the existing southbound bridge in its current locations. The existing northbound bridge will be demolished, and the approach roadways removed. The new bridge spans are proposed to have approximately 72-foot single spans and provide a minimum of 16'-6" vertical clearance over Franklin Street. The proposed paved roadway width are 56 feet each, with 12-foot travel lanes, an 18-foot inside shoulder and a 14-foot outside shoulder. The increased vertical clearances require the approaches to the bridges be reconstructed to meet the new bridge elevations. Franklin Street will be reconstructed within the project limits with full-depth pavement, new curbing, and sidewalks.

SRTS Infrastructure Project Funding Program

Applications for Safe Routes to School (SRTS) Infrastructure Projects will be accepted from Monday, October 3, 2022 to Friday, November 18, 2022. Eligible projects include infrastructure projects such as transportation construction and capital improvement projects that will improve safety and/or increase the number of children walking AND biking to school and are located within two miles of a school serving children in any grades between kindergarten and twelfth grade. The infrastructure project must be within the public way or any bicycle or pedestrian pathway or trail. This may include projects on private land that have public access easements or public property that is owned by a public entity. Projects may be completed on state-owned roadways. Schools that serve any grade between kindergarten and twelfth grade are eligible to receive funding for infrastructure improvements.

FHWA Approves MassDOT Plan for EV Charging Stations on Major Highway Corridors in Massachusetts

BOSTON - The Federal Highway Administration (FHWA) has approved MassDOT's Electric Vehicle (EV) Infrastructure Deployment Plan, which was developed as part of the National Electric Vehicle Infrastructure ("NEVI") Program. FHWA notified MassDOT the state is among the first group of states to have its EV Deployment Plan approved.

"The federal government's approval of our plan is an important milestone in efforts to support the Commonwealth's transition towards low-carbon transportation," **said Transportation Secretary and CEO Jamey Tesler**. "Implementation of the plan will help EV buyers know they will be able to charge their vehicles on major highways in Massachusetts when they take long-distance trips."

Through the NEVI program, Massachusetts will receive significant formula funding over five years, including approximately \$9.4 million for Federal Fiscal Year 2022. These formula funds are dedicated to supporting the construction and operation of Direct Current Fast Charging (DCFC) stations along EV Alternative Fuel Corridors as designated by FHWA.

The Commonwealth's plan aims to establish a financially sustainable, equitable, and complete network of NEVI-funded fast-charging stations to support travelers taking long-distance trips in electric vehicles. The process to build out and maintain a reliable charging network will be a transparent and competitive process, and will be complementary to other ongoing federal, state, and local initiatives supporting EV adoption.

The federal government is in the process of establishing regulations setting minimum standards and requirements for charging equipment funded under the NEVI program. After this rulemaking is finalized, MassDOT will initiate a solicitation for a private partner to support implementation of the NEVI Plan.

Summary

The South Coast Rail (SCR) project will restore commuter rail service between Boston and southeastern Massachusetts by the end of 2023. Taunton, Fall River, and New Bedford are the only major cities within 50 miles of Boston that do not currently have commuter rail service to Boston. SCR will reconnect this region to jobs and generate economic development.

South Coast Rail consists of two phases:

Phase 1 will provide a one-seat ride by extending the existing Middleborough/Lakeville commuter rail line from Boston to Taunton, Fall River, and New Bedford and it will deliver service to the South Coast by late 2023.

Full Build plans to extend Commuter Rail service to continue travel on the Stoughton branch of the Providence/Stoughton line, connecting to more communities in the region. Doing so would result in reconstructing the Canton Center and Stoughton stations to accommodate two rail lines.

In September 2022, work conducted involved continued fencing installation in eight communities on Fall River & Middleborough Secondary Lines and New Bedford Main Line; utilizing Cotley Street in Berkley to access right-of-way (ROW) for various project activities; 24-hour track work in Assonet, Berkley, Lakeville, Middleborough, Raynham, and Taunton; 24-hour crossing work in Freetown and New Bedford; daytime and overnight track work in Lakeville, Middleborough, Raynham, and Taunton; daytime crossing work in New Bedford; daytime work at Fall River Depot and Freetown Station sites; a detour in Fall River for bridge work; daytime roadwork on Route 105 in Middleborough, and improvements to the CSX Rail Yard in Middleborough.

Additional work done included daytime construction at station sites, layover sites, and along the right-of-way from Middleborough to New Bedford as well as along the right-of-way from Berkley to Fall River. There was also overnight and daytime transportation of soils by truck to designated project sites as well as detours for various project activities.


Route 18 Corridor Study Purpose and Scope

Develop short-term and longterm recommendations (specific improvement projects) to decrease traffic congestion and improve safety, circulation, and mobility for all road users (including bicyclists and walkers), as well as coordinate planned transportation improvements with planned economic development and land use changes.


Route 18 Corridor Study Geographic Scope

The study focuses on:

- Traffic volumes, average daily traffic (24hour), speeds, heavy vehicle volumes, and peak hour intersection turning movement volumes and intersection congestion
- Bottlenecks
- Peak Hour levels-of service at key intersections (delay measurement, LOS A to F)
- Safety Number and types of crashes and crash rates, problematic locations
- The condition of the built environment including pavement, sidewalks, pavement markings, traffic control devices and signage
- Transit operations
- Bicycle and pedestrian safety and accommodations (and access to transit)
- Truck operations and constraints (turning radii, height and weight restrictions)
- Changing land use and zoning and the potential impacts of land use on traffic and transportation
- Environmental conditions (wetlands, flooding)
- The study's final report will be completed in September 2023



The Long-Range Transportation Plan (LRTP) is the policy and visioning document of the Metropolitan planning Organization (MPO). This document results from regional and statewide collaboration and consensus on a region's transportation system and serves as the defining vision for the region. The document also contains a financial plan or budget which guides and shapes the actions an MPO undertakes as they fulfill the region's visions and objectives. This 20-year transportation vision document is updated every four years by the MPO, and this update will provide a vision for the region through 2050.

Development of the P2050 Long Range Transportation Plan has begun. With Old Colony Planning Council actively working with other MPOs and MassDOT to develop socioeconomic data forecasts through 2050. This effort began in Spring 2022 and will carry through the Spring of 2023.
