Old Colony Planning Council Receives \$1,990,620 Prioritization Process Pilot Program Award from the Federal Highway Administration

BROCKTON, MA - Old Colony Planning Council (OCPC) has been awarded a Federal Highway Administration Award in the amount of \$1,990,620. This award is one of sixteen across the country and only one of two in the Commonwealth of Massachusetts. The funding will support the development and implementation of a transportation prioritization process for the Transportation Improvement Program (TIP), Long Range Transportation Plan (LRTP), and Unified Planning Work Program (UPWP).

The program aims to improve how transportation projects are planned, evaluated, and implemented within the Old Colony Metropolitan Planning Organization (MPO) region by promoting safety, environmental sustainability, equity, public participation, and workforce development.

Through continuous public feedback and engagement with residents and stakeholders within the region, and implementation of a data-drive approach, OCPC plans to develop and implement a publicly accessible, transparent prioritization process for the ranking and selection of projects for inclusion in short-range and long-range transportation plans.

OCPC is committed to public participation and transparency throughout the prioritization process and engaging stakeholders within our region.

Becky Coletta, President of Old Colony Planning Council, said, "Old Colony Planning Council's staff took the initiative to apply for these funds and that speaks volumes about the care and compassion they have for our 17 communities. Under the leadership of Executive Director, Mary Waldron, Paul Umano, Senior Grants Development Specialist, and Charles Kilmer, Deputy Director and Transportation Program Manager, took the lead and recognized the record investments and opportunities provided by the Bipartisan Infrastructure Law (BIL) to address the needs of our communities. On behalf of all of our Council members, we truly extend our gratitude to Senator Warren, Senator Markey, Congressman Lynch, and Congressman Keating, and their respective Congressional Offices for their continued support for our region."

The project has also garnered strong support from federal and state representatives. **Senator Edward Markey** commented, "Old Colony Planning Council is planning for a brighter future for
