#### E-Bike Laws in MA

- Class 1: Pedal Assist Only. Assistance stops at 20 mph
- Class 2: Has a throttle, stops assistance at 20 mph
- No license, registration, or license plate is required
- If Class 1 or 2 exceed 20 mph, or 750W, may be defined as motorized bicycle, which does require registration

#### Where You Can Ride

- On roadways and bike lanes
- On most bike paths and paved trails, unless local jurisdictions prohibit them

#### Where you Can't Ride

- On sidewalks, statewide.
- On natural surface trails (e.g., mountain-bike type trails), unless a local authority specifically permits it

#### **State Parks**

Only Class 1 E-Bikes are allowed on trails with sufficient width.

#### **Special Commission on Micromobility - Meeting #3**

Tuesday, September 16, 2025, 10 a.m. - 12 p.m., 10 Park Plaza, Boston, MA 02116

<u>Session Law Acts of 2024, Chapter 238, Section 306</u> provided for the formation of a Special Commission on Micromobility. The Commission is charged with producing a study that includes:

A review of current state and local laws and regulations for micromobility vehicles;

Recommendations to regulate micromobility vehicles, including on bike paths, sidewalks and shared use paths; and

Recommendations to support the expansion of micromobility vehicle use and innovation including shared micromobility options for municipalities.

The commission shall file a report of its findings and recommendations with the clerks of the senate and house of representatives and the senate and house committees on ways and means not later than December 1, 2025.
