#### 4. Brockton Area Transit (BAT) Report

Michael Lambert reported on the following items:

- Ridership remains strong at 12,000–13,000 passengers daily.
- FY annual ridership will fall just short of 4 million passengers.
- BAT continues piloting overnight subsidized Uber trips for employment commuters (9 PM-6 AM). Initial
  rollout is focused on Home Depot employees, with expansion planned. The Town of Avon expressed
  interest in helping to publicize the program.

#### 5. Greater Attleboro Taunton Regional Transit Authority (GATRA) Report

Mary Ellen DeFrias reported on the following items:

- Ridership recovery continues post-COVID.
- Reviewing micro transit service for potential expansion using supplemental budget funding.
- Service has not been updated since inception; review aims to improve access and rider benefits.

#### 9. Vision Zero and The Safe System Approach Overview

Bill McNulty discussed Vision Zero and the Safe System Approach. Through its Vision 2050 Long Range Transportation Plan (endorsed September 2023), the Old Colony MPO adopted a Vision Zero Goal for Safety, and described how it would implement the Safe System Approach to work towards its Vision Zero goal. Building upon the fundamental principle that the loss of life and preventable serious injuries are not acceptable, Vision Zero is a strategy to eliminate all traffic fatalities and severe injuries, while increasing safe, healthy, equitable mobility for all. First implemented in Sweden in the 1990s, Vision Zero has proved successful across Europe and now it is gaining momentum in the United States and American metropolitan areas.

The Safe System Approach prioritizes the elimination of crashes that result in fatal and serious injuries. It moves beyond a traditional safety approach to both prevent crashes from happening in the first place and to mitigate the harm caused by crashes that do occur. The Commonwealth of Massachusetts adopted the Safe System Approach in the 2023 Strategic Highway Safety Plan.

Dan Salvucci raised concerns about electric scooters and youth safety. Bill McNulty noted that while no local data shows increase in incidents, OCPC will monitor trends through its safety management system.

#### 10. 2024 Measures of Effectiveness (MOE) Report

Shawn Bailey provided an overview of the 2024 MOE Report. Public Participation is a key ingredient in the Old Colony Metropolitan Planning Organization (MPO) transportation planning efforts. Public Participation not only leads to better projects, studies, and outcomes, but also helps spend limited funding in a manner in line with community and regional goals. In addition to helping develop better projects, public outreach fosters greater trust between citizens and Local, State, and the Federal Government and their representative entities like the Old Colony MPO. Lastly, the MPO is required by State and Federal partners to ensure it is including members of the public in the transportation planning process.

In order to ensure the Old Colony MPO is meeting its public participation requirements, measures are necessary to determine whether its Public Participation Plan (PPP) is accomplishing its goals. Through a series of data collection efforts that take place during outreach efforts, the MPO obtains the ability to see where the PPP is succeeding and where there are opportunities for greater participation. This report explores outreach efforts and

measures their effectiveness in expanding public participation to members of the public and outside organizations in MPO planning activities.

In order to better understand how the MPO is meeting its commitment to fostering public engagement in all MPO planning activities, it is key to develop a series of measurements to understand the effectiveness of the public outreach efforts. It is through the tracking of public engagements, whether it be in person, via email, through social media or utilizing virtual public engagement, that the MPO can determine if its public outreach efforts are delivering the results that are desired and required.

The Old Colony MPO tracks all the outreach efforts it conducts. Public meeting attendance is recorded with additional attention given to attendees that are from Title VI protected classes. The MPO tracks the methods it employs in getting information to the public on upcoming meetings, the release of public documents, and the viewing and engagement of the public through its social media presence. Through the collection of this information the MPO gains greater clarity on where it is doing well and where there is a need to increase public engagement.
